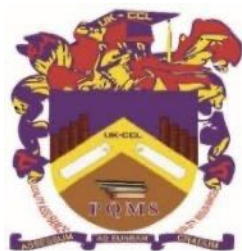

**Compulsory Required Supporting Documents**



- a) Submission of a detailed CV Synopsis with a detailed explanation of Professional History and the key achievements and specialty work experience. This will determine UKCCL to recommend the appropriate professional awarding scheme and procedures.
- b) Respective Awarding Institution's completed application form with One Passport Size Colour Photo and all other relevant supporting documents to confirm the award eligibility.
- c) It is a mandatory requirement that all supporting documents have to be witnessed and certified as the True Copies of the original by a non-relative practicing legal professional.
- d) Certified Scan Photocopies of Educational, Professional, and Vocational Certifications.
- e) Certified Scan Photocopies of Recommendation, Gratification, Appreciation letters, and Reference Letters confirming the suitability for the Lifelong Learning Professional Knowledge Awards.
- f) Three Non-Relative Personal Professional Recommendations must be available for a minimum of three Verbal Viva Consultations.
