UK-CKA Learning Faculties & Qualifying Structure

The UK-Certified Knowledge Association (UKCKA) Formerly Known as The Corporation of Executive Administrators (CEA) Executive Board of Governors met on the 28th, of September 2022 and passed a new resolution unanimously to consolidate their Lifelong Blended Knowledge Learning Academies within Fourteen Academies. This came into effect on 1st October 2022, due to the affiliation of the London School of Media & Management (LSMM) as the Online Blended Learning Campus in facilitating Learning, Invigilation, and Assessments to ascertain the eligibility for the Professional Awards of UKCKA with the Verification Executed by UK Commission for Consistent Learning (UKCCL).

The Awarding Graduations will be held every January, April, July, and October each year to assess, verify and confirm the appropriate UKCKA's Career Progressive Professional Knowledge Qualifications. UK-CKA Professional Knowledge Qualifications are considered to be the Equivalent Quality Standards of the National Vocational Qualification Framework (NVQF) and National Vocational Quality Standard (NVQS). UK-CKA publication Admin Times and Admin World has official approval from the British Library on the 15th, of October 1993 with the International Standard Serial Number ISSN 1352-0091.

It is emphasized that the UK-CKA Professional Qualifications are awarded by Lifelong Blended Knowledge Learning Methodology. Learning Academies are comprised of individual Learning Faculties long with appropriate Course Modules Units, but each level of qualifications will have a standard number of mandatories requirements per each modular unit. After careful consideration of the level of qualifications, the Executive Board of Trustees & Governors concluded that the UK-CKA's Lifelong Blended Knowledge Learning awards are in accordance with the equivalent to the Framework to the European General Learning Level of 2008. It is also made clearly made known to every applicant who follows the Lifelong Blended Progressive Learning Methodology must submit a Career Project Work (CPW) Assignment as the final written documentation and must attend a minimum of Two Oral Consultations. The Assessment and Verification for the Module Units

(1) Time-Bound Assignments (TBA) 50%, (2) Individual / Group Assignment 15%,(3) PowerPoint Presentations for Certain Modules 10% (4) Open Book Examination (OBE) 15%,(5) Viva Examination 10%

The Final Oral (Viva) Examination is to test the candidate's knowledge in Critical thinking of contemporary issues. This will be carried out on an individual basis by Oral Discussion with the qualified intellectual academics nominated by the UK-CKA Examination Panel. This can take up to a maximum of 60 minutes. The Viva Examination is to tests the candidate for the overall knowledge needed for the qualifications. It has been agreed by UK-CCL that for the candidate to obtain the UK-CKA Learning Diploma Qualification, they must have achieved at least a Grade C Level in all

module units. Failure to gain this grade means that UK-CKA will not recommend any candidate for the UK-CKA Professional Diploma award, and it is agreed that no candidate will be entertained to question the decision of the UK-CKA Examiners' declaration.

The Learning Hours and Credits Units are specific to the UK-CKA Learning Programmes, which have the approval of the UK-CKA Executive Board Governors. (In the past the National Qualifications Framework (NQF) has been changed to Qualifications and Credit Frame (QCF) and this change came into effect in November 2008.) Since 2009 in order to meet the QCF standards, the UK-CKA has changed its syllabus structure. As always, UK-CKA Learning is focused more on a Professional Knowledge Methodology rather than a pure academic scheme. This vision of theirs has led the pathway for Blended Learning with Open Book Examinations and the submission of Assignments and Viva Consultations. Most of the institutions are still adapting to the traditional three-hour classroom examination. The current climate and Professional concept do prefer consistent assessment. All Levels will comprise Three Modules. Every January, April, July, and October each year, candidates will be assessed and verified for the UK-CKA Professional Qualifications. The credit Units have been allocated as UK-CKA Levels 1, 2, 3, and 4 will give the recommended accumulated credits of 240, and Level 5 is to be 120.
